<p>Leon County PUD Concept Plans are now accepted every other week at the Leon County Development Support and Environmental Management Office. The applicant is required to complete a pre-application meeting and a technical review meeting prior to submitting the final PUD application for DRC review. Immediately after the DRC vote, the DRC chairman will place the application on the next available Planning Commission and Board of County Commissioners agendas. DRC meetings are held every 1st and 3rd Wednesday, and applications are due two weeks prior.
