

RESOLUTION NO. 94-R-0030(AA)

A RESOLUTION IDENTIFYING MODIFICATIONS TO THE LIST OF CAPITAL PROJECTS TO BE FUNDED FROM THE CITY OF TALLAHASSEE'S SHARE OF THE LOCAL OPTION ONE-CENT SALES TAX

WHEREAS, Leon County voters approved a Local Option One-Cent Sales Tax by referendum on September 19, 1989, which is effective from December 1, 1989 until November 30, 2004, and

WHEREAS, the City Commission adopted a Resolution No. 89-R-0024 on August 30, 1989, identifying the Capital Projects the City of Tallahassee is committed to constructing with its share of these additional Sales Tax Revenues, and

WHEREAS, Resolution No. 89-R-0024 provided the list of Capital Projects may be amended by the City Commission, and

WHEREAS, the City Commission adopted a policy on March 10, 1993, which provides for annual review of the Sales Tax Capital Project, holding a public hearing if revisions are needed, and affecting revisions to the Capital Projects List by resolution adoption,

NOW, THEREFORE, be it resolved that the City Commission, pursuant to its commitments and policy, amends the City of Tallahassee's Sales Tax Capital Projects List, contained in its Resolution No. 89-R-0024, by adding the following projects to the indicated sections:

- A. Advance Funding of State Road Projects
 - * 11. Apalachee Parkway (Magnolia to Southwood Plantation Road)
 - 12. I-10/Capital Circle West Bound Ramp
 - 13. South Monroe Street (Paul Russell to Perkins)
 - 14. Thomasville Road Fringe Roads

- C. City Law Enforcement Project
 - 2. Westside and Southside Police Substations

D. City Projects

16. Call Street PASS (Tennessee to Murphree)
17. Orange Avenue Extension, Phase I (Paul Russell to Capital Circle)
18. Conner Blvd. (Four-lane from Capital Circle to Trojan Trail)

E. Intersection Improvements




