ENVIRONMENTAL PERMIT CHECKLIST

FEE: Fees for LDO, MINOR, and STD projects are compound fees. This means that individual assessments for each component (stormwater, landscaping and tree removal) are added together for a total fee. Not all projects will involve landscaping or tree removal, so fees for these projects must be calculated on a case-by-case basis. Refer to the **Fee Schedule** form to determine the appropriate fee amount.

Submittal Requirements:

- _____ 1. The application form is complete with all blanks filled in or marked "N/A" as not applicable.
- _____ 2. Copy of the Site Plan FINAL Approval letter. If there was no site plan review required, then a copy of the EIA approval or NFI/EIA exemption letter must be provided or an application for an EIA must be included with this submittal.
- _____ 3. A location map provided on the site plan or attached as a separate document.
- _____ 4. Project statement or narrative. This may be a single page document, part of a report, or part of the site plan.
- _____ 5. Completed "Affidavit of Ownership and Designation of Agent" (must be an original).
- _____ 6. Two (2) sets of plans are required at time of submittal. Four (4) sets are required if the project is for a subdivision with publicly dedicated streets and drainage. Additional sets will be required before permit issuance. Plans must contain embossed seal, signature, and date.
- _____ 7. Certified copy of the Stormwater Management Design Report.
- _____ 8. The application fee shall be paid at time of submittal. Department of Transportation (DOT) is exempt from paying fees. Leon County School Board is approved to pay by purchase order. City projects should use a budget transfer memo and should be submitted with the application.
- _____ 9. Color documents should also be submitted in electronic form in one of the following formats: .tif, .pdf, .jpeg, or .bmp.
